The Democratization of Vulnerable Bodies: Feminist Readings of Neoliberal Authoritarianism

Seminar Description

The current scenario, marked by the crisis of democracies and the global rise of the extreme right, leads to the question: What is the relationship between these phenomena and the neoliberal economic system? The early history of neoliberalism, which began with the alliance between the Chicago Boys trained by Milton Friedman and authoritarian forces, indicates that neoliberal policies themselves harbor authoritarian tendencies. The research field of decolonial feminism currently includes approaches that examine this linkage and emphasize the gender-political connections. They offer conceptual tools for critical diagnosis of the present and produce resistant knowledge in dialogue with social struggles and political movements such as Ni Una Menos, the feminist strike movement. Some of their key focuses are the rehabilitation of the concept of patriarchy, the relationship between economic violence and gender-based violence, the gendered and colonial dimensions of austerity policies, the politics of states of exception and shock therapies, the financialization of reproductive labor, the effects of bio- and necropolitics on subjectivities and the treatment of the life and death of particular bodies. Race, gender, and class are central concepts in these reflections. We will discuss seminal texts in this debate to create a cartography of the key concepts these authors use to explore the intersections between authoritarianism and neoliberalism. It will lead us to understand the dynamics of neoliberal authoritarianism and the transnational uses of these theories.

The seminar will be held in English, but if students have knowledge of Spanish and/or Portuguese, this would be an advantage, as some additional texts will be provided in original languages-
